- PPE and necessary items for the safety of everyone involved
- Hosting PIT count events in rural communities
- Developing maps for PIT count surveyors using GIS
- Creating local questions for the PIT survey
- Purchasing the annual license to use the “Counting US” mobile application
- Distributing surveys to participating agencies.

Activities related to community engagement with the Collaborative Application process include (but are not limited to):

- Engaging with community partners through site visits to understand their work and recruit and support new CoC members
- Annual evaluations and reports
- Recruitment and selection of Project Evaluation Work Group.
- Development and implementation of the Rating and Ranking Tool
- Creation and posting of the local RFP
- Assisting project applicants
- Attending HUD trainings and providing support for HUD-required reporting

2025 PIT:

- The work for the 2025 PIT count will begin in November 2024;
- Purchase of license for Counting US and training will begin in November 2024 and proceed through mid-January to ensure all agencies, teams, and volunteers are trained;
- Development of the survey and production of non-digital formats for use as needed;
- Outreach to all communities to raise awareness of the PIT and to solicit broad participation;
- Compilation, consolidation, and reporting of PIT information to HUD in Spring 2025 as required;

Jackson County, Oregon faces many of the same issues surrounding homelessness as other municipalities. The significant difference here is the Almeda and Obenchain wildfires of September 2020 that both increased the number of homeless individuals and families and decreased the housing inventory for the area. Although much rebuilding has occurred, the region is still striving to fully recover. The region is still struggling to rebound. This CoC Planning application seeks to:

- Reach and engage additional agencies that represent the two groups most impacted by the wildfires – the Hispanic migrant worker community and the elderly;
 - Discover relevant access points and create partnerships to ensure appropriate, timely, and culturally sensitive strategies for information and resource dissemination;
 - Continue to expand access for rural communities through existing touch points including libraries, food pantries, churches, other community centers;
 - Build healthier communities by addressing the social determinants of health through coordination of services across disciplines (housing, health care, recovery services, mental health, etc.);
- These activities are ongoing. They inform the rebuilding and recovery work of our region and direct our next steps to safe and stable housing for everyone.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

With the increased county-wide participation in HMIS and the emphasis on improved data quality, the CoC will be in a much improved position to evaluate the outcome of CoC and ESG projects. Through site visits to service providers receiving CoC and ESG funding, analysis of system performance measures, and review of CAPER and APR's, the CoC will evaluate performance and offer support and guidance to poor performers. The CoC has developed written standards for ESG and CoC projects, which provide evaluation guidance, as well.
